- Camp fees are due on the last day of the month prior to attendance. Late charge of \$25 will be assessed if fee is not paid, unless approved by Amy Hatcher.
- Our Summer Camp is open 7:30 am 6:00 pm. It is IMPERATIVE that your child be picked up by this time; this is a shared facility, and there may be other functions which will begin after 6:00pm.
